Understanding and addressing mental health reactions to a global pandemic

COVID-19 initiated a global mental health crisis. Understanding the scope and breadth of pandemic mental health impacts is critical to inform interventions and to prevent similar impacts in future global crises. We will present studies aimed to understand and mitigate these impacts. Professor Jinhee Hyun will present population-level data measured quarterly throughout 2022 in prevalence of positive screenings for PTSD, depression and suicidal thoughts in South Korea. Professor Nicole Nugent will report on prevalence of PTSD and ways of seeking support before and during the pandemic among adolescents recruited from an emergency department following a potentially traumatic event. Professor Erika Felix will describe findings from a needs assessment of teachers' experiences during the pandemic and a training to help administrators respond to teachers' needs. Professor Sonya Norman will present results of a randomized controlled trial of treating guilt and related distress stemming from traumatic or potentially morally injurious pandemic experiences.
